

PARENT/GUARDIAN (OR ATHLETE) ACKNOWLEDGEMENT OF ATHLETE ELIGIBILITY

As required under the Fairness and Safety in Sport Regulation (Alberta)

The Government of Alberta's Fairness and Safety in Sport Act and accompanying Fairness and Safety in Sport Regulation require that all athletes aged 12 and older who wish to participate in female-only Athletic leagues, classes or divisions in our schools must meet a specific eligibility requirement.

Under the Fairness and Safety in Sport Regulation, parents or guardians of minor athletes aged 12 to 17 (or the athlete, if 18 or older) must confirm that the eligibility requirement set out in the legislation is being met for participation in female-only school athletic leagues, classes, or divisions of relevant sports. This written confirmation (through the completion of this Athlete Eligibility Form) must be provided at the time of registration for the sport, regardless of whether the athlete has previously participated in the sport.

Eligibility Requirements

Under Section 3 of the Fairness and Safety in Sport Regulation, eligibility to participate in female-only sport divisions is limited to athletes whose sex at birth is female, as indicated on their birth registration document.

Acknowledgement and Confirmation
